
- Town Highway # 45 Black Road

- Town Highway # 46 Coos Trail

*Reclassification of a portion of the Class 3 section of Coos Trail beginning immediately past the driveway of 309 Coos Trail to where the current Class 4 section of the road starts at the former Town Dump Property to a Class 4 Town Highway.*
