**Public Comment – None**

**Maintenance –**

Ron Mercier reviewed preventative maintenance sheets that will be sent requesting quotes for annual maintenance contracts for generators at the Main, Partridge Farm; Shaw's and the Town Garage Generators. Wayne Lamberton added that in the future when the inspections are done a representative from the Sewer Commission should go with them. Ron Mercier was given approval to solicit quotes, Motion made by Henry LaGue; 2<sup>nd</sup> by Lamberton. Vote – all in favor.

Montpelier Public Works – Ron advised after MPW swapped samplers (which belongs to them) at the Main Pump Station it was discovered that the flow meter did not work afterwards. Ron has discussed who is responsible for the repair of the meter with MPW's. It was suggested that Ron and the electrician meet at the Main Pump Station and call Sullivan Inc. in Maine and ask to have a diagram sent so the meter could be repaired.
